**Schedule 1-IK - Itemized In-Kind Contributions:**

Contribution #2 reports a purchase by M. Doppel; as such, Item #6 - name and address of the vendor paid, should be completed.

**Schedule 1E - Debts and Obligations:**

The \$2,000.00 loan from the candidate reported on Schedule 1A should also appear on Schedule 1E. Please clarify.

**Schedule 1F - Fund Raiser:**

Line 7 should report the total amount of contributions received by the committee for its fund raising event.
