Please clarify the dates for the contributions from Iron Workers and Plumbers Local 98; reported as 1/22/17 & 12/28/20 respectively.

#### Schedule 1A-1 - Itemized Other Receipts:

You reported a date of 7/26/18 for the refund from Friends of Nate Shannon. If that date is correct, the refund should instead appear on your next due statement since it occurred after the coverage period of your July Qtrly. Removing it from this statement will affect the Summary Page. Please clarify.

#### Schedule 1B - Itemized Expenditures:

The \$539.76 refund reported from Friends of Nate Shannon on Sched 1A-1 does not appear to have been reported as an itemized expenditure from your committee to Friends of Nate Shannon on Sched 1B. Adding it to Sched 1B will affect the Summary Page. Please clarify.

The \$5.40 expenditure to Act Blue Donate has a date of 7/26/18. If that date is correct, this expenditure should instead appear on your next due statement. Removing it from this statement will affect the Summary Page.

The \$400 loan payment reported on Sched 1E should also be reported as an itemized expenditure to the candidate on Sched 1B. Adding it to Sched 1B will affect the Summary Page.

#### Schedule 1E - Debts and Obligations:

Sched 1E reports a \$400 payment made on 7/26/18. If that date is correct, the payment should instead appear on both Schedules 1B and 1E of your next due statement and Line 12a of the Summary Page of this statement will be affected. Please clarify.
