Contribution #4 on pg 2 was reported as a PAC Receipt from Schor for Lansing. We are unable to identify a registered PAC by that name; please provide the complete, registered name of this contributor.

Contribution #1 on pg 3 was reported as a Direct contribution from candidate committee CTE Terry Sabo. Candidate committees are prohibited from accepting contributions from other candidate committees except for the purchase of fund raiser tickets. If for a fund raiser, the "Fund Raiser" box should be checked. If not, the following steps should be taken:

- 1. Immediately return the contribution to the contributor.
- 2. Forward proof of return to our office as soon as possible.
- 3. Report the transaction as an expenditure on your next due campaign statement.

Please clarify.

The wrong form was used to report your committee's expenditures. You used Schedule 2B, (for Independent or Political Committees). You should instead be using Schedule 1B, (for Candidate Committees).

#4 on pg 11 reports a Donation to candidate committee Write In Henry Newnan. Candidate committees are prohibited from making contributions to other candidate committees except for the purchase of fund raiser tickets. If for a fund raiser, the "Fund Raiser" box should be checked. If not, the following steps should be taken:

- 1. Immediately request that the donation be returned to your committee..
- 2. Forward proof of return to our office as soon as possible.
- 3. Report the refund as "Other Receipts" on Schedule 1A-1 on your next due statement.

Please clarify.

A description should be provided under "Purpose" for:

#3 on pg 9 - Gordon Food Services - \$61.94 #3 on pg 10 - Better Health - \$20.15

#1 on pg 10 (Meijer) reports a date of 10/25/19. If that date is correct, this expenditure occurred after the coverage period (10/20/19) and should not appear on this statement. Removing it will also affect the Summary Page. Please clarify.

Please amend your statement accordingly and forward to us by November 26, 2019.
