Summary Page:

When added together, the in-kind contributions listed on Schedule 1-IK total \$1,227.38 instead of \$1,227.48 as reported on Line 6. See note under Schedule 1-IK below for possible source of discrepancy. Please clarify.

Line 12a reports debt of \$22,363.26, however, new loans marked on Schedule 1-IK totaling \$821.38 added to previous loans of \$21,135.78 equal \$21,957.16. See notes under Schedule 1-IK and Schedule 1E for possible source of discrepancy. Please clarify.

Schedule 1-IK - Itemized In-Kind Contributions:

Based on the contributions reported, page 1 subtotal should be \$407.22 instead of \$407.32, for a total of all In-Kind contributions of \$1,227.38. Line 6 of the Summary Page would be affected. Please clarify.

Contribution #3 on page 1 (Facebook advertising \$400) and contribution #3 on page 2 (G Suite email \$6) are missing the type of contribution and may be the source of discrepancy on Line 12a of the Summary Page and Schedule 1E. Line 12a of the Summary Page would be affected.

Based on your Late Contribution Report submitted 8/2/21, your Post-Primary should report contributions from Michael Radtke totaling \$\$814.94 as having been received by your committee between 7/19/21 and 7/31/21. The Post-Primary reports contributions from him of only \$\$814.84. The previously filed LCR might need to be amended. Please clarify.

Schedule 1E - Debts and Obligations:

Debt #3 on page 6 reports \$1,227.48 in loans during the period of 7/19/21-8/23/21, however only \$821.38 are marked as loans on this statement. Note: The discrepancy cited above under Schedule 1-IK regarding the page 1 subtotal may affect the total debt reported on Line 12a of the Summary Page. Please clarify.

Please amend your statement accordingly and forward to us by September 16, 2021.
