Line 12a should show the \$13,839.25 debt reported on your previous statement. All unpaid debt must continue to be reported on Line 12a until such time as the debt is either repaid or forgiven.

Lines 14 - 17 cannot be verified until the following issues are addressed:

Schedule 1A - Itemized Contributions:

If Contribution #3 on page 1 from Sterling Heights Utica Republicans was from a PAC, the "PAC Receipt?" box should also be checked.

In addition, the source of this contribution is unclear. It indicates as coming from a possible PAC but also includes occupation and employer info as if from an individual and an individuals name. If from an individual, only that person's name should be listed as the contributor. If from a PAC, occupation and employer info is not necessary.

Also, the Address and Type of Contribution is required for Sterling Heights Utica Republicans/Richard Bracci. Please clarify.

Contribution #2 on page 2, Michael Moreau, reported a date of 8/30/21. If that date is correct, this contribution should instead be reported on your next due statement (2021 Pre General). Removing it from this one will also affect Lines 3a, 3c, 5, 14, 15 and 17 of the Summary Page. Please clarify.

Schedule 1B - Itemized Expenditures:

The expenditure to Macomb Daily (\$500.00) was reported as having occurred on 7/7/21. If that date is correct, this expenditure should not appear on this statement since that date is before this coverage period (7/19/21 - 8/23/21. In addition, if that date is correct it should instead have appeared on your 2021 Pre Primary statement, necessitating amending both that statement and this one. Removing it will also affect the Summary Page. Please clarify.

An Address is required for the following expenditures:

- #1 Macomb Daily, Full Page Ad (if it remains on this statement)
- #2 Facebook, Facebook Political Ads
- #4 Facebook, Facebook Ads

Schedule 1E - Debts and Obligations:
