Please amend Lines 3a, 3c and 5 to properly report contributions of \$3,209.10 as shown on Line 14 of the Summary Page.

Lines 8a and 8b still appear to have a duplicated amount. See note under Schedule 1B and 1B-G below.

Schedule 1-IK - Itemized In-Kind Contributions:

The following was overlooked on your recent amendment and still needs to be addressed:

Please clarify the Type of Contribution for the entries from Paul Smith. They were specified as "Goods Donated or Loaned" but also included a Vendor Name and Address; indicating a vendor had been paid. If the Ads were purchased, it should instead be specified as "Goods or Services Purchased by Candidate or Others" or "Goods or Services Purchased by Candidate or Others - LOAN". If donated, a Vendor Name and Address need not be included.

Follow Up Note: Schedule 1-IK was not submitted with this amendment.

Schedule 1B - Itemized Expenditures:

It appears the following expenditure may be a duplicate:

Expenditure #4 on page 1 - Got Print 10/14/21 - \$86.03

This expenditure was also reported on Schedule 1B-G for the same amount, to the same vendor, on the same date. If a single expenditure was made to Got Print on 10/14/21 for \$86.03 it should only be reported on EITHER Schedule 1B OR Schedule 1B-G. If 2 expenditures were made to this company for the same amount on the same date, they would both be reported on the same Schedule. Removing one will also affect the Summary Page.

Please clarify.

Schedule 1B-G - Get-Out-The-Vote Activities:

See note above for possible duplicate expenditure reported. If it is a duplication, removing it will affect Lines 8a, 8b, 9, 16 and 17 of the Summary Page.
