Total in-kind contributions of \$3,455.63 listed on Schedule 1-IK should be reported on Line 6 of the Summary Page. Since activity was reported on Schedule 1-IK, it also needs to be included on the Summary Page even thought it was reimbursed on this same statement.

Line 13 should be \$19,487.80 instead of \$19,478.80; based on the Ending Balance of your 2022 Annual. Lines 15 & 17 will also be affected. Please clarify.

### Schedule 1-IK - Itemized In-Kind Contributions:

In-Kind contribution #1 on page 1 was reported as paid to Michael C. Taylor for Vehicle Expenses. Per the committee manual (See Expenditures and Disbursements - Candidate Uses Personal Vehicle section for further clarification), a log must be maintained documenting the number of miles driven along with the rate and purpose. "This information is required to be disclosed on a campaign statement." Please provide memo-itemization for this activity.

#### Schedule 1B - Itemized Expenditures:

Expenditure #4 on page 1, Michael C. Taylor - \$3,445.63 reported a date of 11/10/22. If that date is correct, this expenditure should instead have appeared on your previous statement, necessitating amending that statement and this one. Lines 16 & 17 of the Summary Page could be affected.

Note - in the box immediately following of Expenditure #5 it states "Expenditure #2 is a repayment of....." This statement should reference Expenditure #4, not #2.

#### Schedule 1E - Debts and Obligations:

The copy of Schedule 1E filed with this statement is illegible. A new copy of this Schedule will be required to be filed with your next statement.
