Outstanding debt reported on line 12a requires clarification. Your Post-Primary Amendment filed on 9/11/06 reported outstanding debt of \$61,682.36. This Pre-General statement reflects outstanding debt of \$56,792.76. Schedule 1E of this statement lists several payments made on 8/23/06 that total the difference of \$4,889.60. However, expenditures for that amount do not appear on Schedule 1B of either filing. If the date of 8/23/06 on Schedule 1E is correct, those expenditures should have been included on Schedule 1B of your Post-Primary statement. Please clarify.

A Date of Receipt is required for Contribution #2 on pg 9 - Steven Urli and also for Contribution #3 on pg 9 - Luciano Gianino.

**Schedule 1B - Itemized Expenditures:**

When added together, the transactions listed on Schedule 1B appear to total \$14,088.64 instead of \$14,388.64 as reported. (Lines 8a, 9, 16 & 17 of the Summary Page will be affected.) Please clarify.
