# Schedule 1-IK - Itemized In-Kind Contributions:

Based on dates reported on your Post-General campaign statement, your committee was required to file a Pre-General statement since it lost the Reporting Waiver prior to the close of books for the Pre-General (Oct 18th). As such, the following action should be taken:

- 1. File a Pre-General statement reporting all transactions that occurred from May 15, 2009 thru October 18, 2009.
- 2. Amend your Post-Gen statment to reflect only transactions that occurred from October 19, 2009 thru November 23, 2009.

A \$2,000 loan was reported from the candidate. If the funds were deposited into the committee's checking account, this transaction should instead appear on Schedule 1A, Itemized Contributions, and will affect the Summary Page. If the candidate paid vendors out-of-pocket with the funds, the entry on Schedule 1-IK needs to be memo-itemized to show the vendors paid, date, amount, and purpose of each expense. In that case, Schedule 1B may be affected. Please clarify.

# **Schedule 1E - Debts and Obligations:**

Column 7 indicates \$2,000 was repaid to the candidate. IF so, both Column 9 of Schedule 1E and line 12a of the Summary Page should instead report \$0 as the amount of outstanding debt. Please clarify.

### Schedule 1F - Fund Raiser:

Both fundraisers report \$0 as the Total Cost of Event on line 10. Please clarify.

Please amend your statement accordingly and forward to us by December 28, 2009.
