Line 12a shows outstanding debt of \$0, but your Pre-Primary statement previously showed debt of \$59,531.76; none of which has been reported as either repaid or forgiven. Schedule 1E should be submitted to show the \$59,531.76 is either still outstanding or repaid/forgiven. If still outstanding, the \$59,531.76 should also appear on line 12a of the Summary Page. Please clarify.

#### Schedule 1B-IK - Itemized In-Kind Expenditures:

The recipient and nature of the expenditure reported on Schedule 1B-IK, Itemized In-Kind Expenditures, is unclear. It was reported as an in-kind expenditure to Frank Pattuna related to a fund raiser and also specified as a donation of goods or services to a Ballot Question Committee. If made to a Ballot Question Committee, the committee's name should appear, instead of Frank Pattuna, along with a description of the goods or services provided. If a direct expenditure to Mr. Pattuna, it should instead be itemized on Schedule 1B. If it was an in-kind contribution, it should instead be reported on Schedule 1-IK. The Summary Page will be affected. Please clarify.
