Schedule 1-IK - Itemized In-Kind Contributions:

Based on the in-kind contributions reported as having occurred on 9/9/09 (James Hunt \$966) and 10/14/09 (Black Finn \$50), your committee lost the Reporting Waiver prior to 10/18/09 and was therefore also required to file the 2009 Pre-General campaign statement. Since the information that would have been disclosed on it was provided on your Post-General campaign statement, it is not necessary to submit a separate 2009 Pre-General statement at this time. However, the late fees for the Pre-General statement that were originally assessed on 12/11/09 are still applicable and need to be addressed. (A copy of the late fee notice is enclosed.)

In addition to the above, a Description and Date of Receipt is required for the in-kind contribution on page 3 from Black Finn. Please clarify.

Schedule 1E - Debts and Obligations:

Two loans appear on Schedule 1E from the candidate on 10/26/09 totaling \$290 (one for \$70 and one for \$220); however, Schedule 1-Ik only itemizes loans from the candidate on that date totaling \$120 (one for \$70 and one for \$50). Please clarify.
