Candidate committees are prohibited from accepting contributions from other candidate committees except for the purchase of fundraiser tickets and only up to \$100.00 per calendar year. If for fundraiser tickets, the "Fund Raiser" box should be checked for each of the above and the following steps should be taken:

1. Your committee should immediately return the excess of \$150.00 to CTE Jeff Sakwa, CTE Vince Bernardi and Horning for Michigan Regent.

- 2. A copy of the return checks should be submitted to our office as soon as possible.
- 3. The transactions should be reported as expenditures on your next due campaign statement.

If not for fundraiser tickets, the following steps should be taken:

1. Your committee should immediately return the entire contribution to all four candidate committees.

2 & 3 - Same as above
