Please amend the following:

Page 1, #1 - A Political Committee may not contribute for an election cycle more than \$500.00 to this Committee. Contributions to candidates are made on an "election cycle" basis. "Election cycle" is defined for the general election, as the period beginning the day following the last general election in which the office appeared on the ballot and ending on the day of the next general election in which the office appears on the ballot.

The following action should be taken if an excess contribution has been given:

1. The committee should correspond with the receiver and inform them that the committee may not accept an excess contribution and that the excess amount must be returned. The Candidate Committee should return the excess contribution immediately.
2. A copy of the correspondence to the Candidate Committee, along with a copy of the Candidate Committee's check showing the return of the contribution, should be filed with this office.
3. The receipt reflecting the contribution that has been returned would then be reported on the next Campaign Statement filed by the committee.

If your response indicates that the committee made an excessive contribution, or if you fail to respond, the person who made the contribution and the committee receiving the contribution will be referred to the Legal and Regulatory Services Administered for further review.
