In view of this, please clarify the nature of this contribution.

The following action should be taken if a corporate contribution was received by the committee:

- 1. The committee should correspond with the corporation and inform them that the committee may not accept a corporate contribution and request that they verify their corporate or non-corporate status. If the entity is incorporated, the committee should return the corporate contribution immediately.
- 2. A copy of the correspondence to the corporation, along with a copy of the committee's check showing the return of the contribution to the corporation, should be filed with this office.
- 3. The expenditure reflecting that the corporate contribution has been returned will then be reported on the next Campaign Statement filed by the committee.

If your response indicates that the committee received a corporate contribution or if you fail to respond, the above name contribution may be referred to the Legal and Regulatory Services Administration for further review.

PLEASE NOTE: If you determine that the contributing entity is not a corporation, written documentation must be provided to substantiate that determination.

If the contribution is not from a corporation, but from a partnership, this must be clearly stated. If the partnership has supplied your committee with a statement attributing its contribution to individual partners, your committee is required to report it as separate contributions from each individual, not from the partnership.
