Schedule 1A - Itemized Contributions:

Please amend the following:

Contributions to candidates are made on an "election cycle" basis. "Election cycle" is defined for the general election, beginning the day following the last general election in which the office appeared on the ballot and ending on the day of the next general election in which the office appears on the ballot. For a special election, an election cycle begins the day a special general election is scheduled or the date the office becomes vacant, whichever is earlier, and ends on the day of the special general election.

Please advise this office of the status of the following contributions by Dov Lustig to your committee which appear to exceed the contribution limit.

The following action should be taken if an excess contribution has been made:

1. You must determine which of the affiliated committees should obtain a refund of the excess contribution.
2. Correspondence should be sent to the recipient candidate committee informing them that affiliated committees are subject to a single contribution limit and that the excess amount must be returned. The candidate committee should return the excess contribution immediately.
3. A copy of the correspondence to the recipient candidate committee, along with a copy of the committee's check showing the return of the contribution, should be filed with this office.
4. The receipt of the returned contribution would then be reported on the next Campaign Statement filed by the committee receiving the refund.

If your response indicates that an excess contribution was made, or if you fail to respond to this notice, your committee may be referred to the Legal and Regulatory Services Administration for further review.
